- 1. The bidder must be a registered manufacturer of the product offered (Accredited Body Builder). Proof of registration must be provided and must be attached to the tender.
- Bidders must provide proof of relevant experience (track record) of previous contracts of a similar nature, scale of complexity over the last five years. Tender must have completed at least one (1) contract of similar nature with a minimum value of R2.5 million.
- 3. Bidders must have a qualified artisan in its employment (CV and trade certificate must be provided and attached to the tender)
- 4. The product must be of a reputable and proven make. (Component specifications complying with the minimum specifications in the component specification must be provided and must be attached to the tender)
- 5. The product parts (consumables) must be available within a reasonable time (3 working days)
- 6. The vehicle must comply with all the relevant aspects of the Road and Traffic Act and regulations.
- 7. A minimum of 3-years guarantee against premature rust perforation of the bodywork shall be applicable to all tender offers.

COMPONENT SPECIFICATION - 15 000 L COMBINATION JET/VACUUM

1. GENERAL DESCRIPTION

- Manufacture and Assemble 1 x 15 000Litre Combination Jetting / Vacuum Unit onto an ISUZU FXZ26 – 360 (OR EQUIVALENT), 6x4 Truck Chassis, automatic transmission.
- Truck Chassis cab included.
- TANK TOTAL CAPACITY: 15 000 Litres
- TANK COMPARTMENTS: 10 000 Litres Vacuum (Sludge Tank)
- 5000 Litres (Clean Water) 2000Lt on main and 6 x 500L Saddle tanks connected to main Water tank.
- TANK MATERIAL: 304L Stainless Steel with Omega rings (OR EQUIVALENT) around tank shell for reinforcement.
- WALL THICKNESS: 4.5MM (Vacuum and Water) with 6mm Toro-spherical Dome Ends

2. TANK

- Cylindrical tank, suitable to withstanding vacuum and pressure.
- The tank is made up of two compartments, one section for water and the other for sludge.
- Two dependent compartments are obtained; the front section is intended for the filling with water (Capacity 5000 Litres) and the rear section for Sludge (10 000 Litres).
- 2.1 The sludge compartment is complete with floating level indicator, Stainless Steel Strainer to separate Sludge from water and a 150mm dump valve mounted at Rear Lower End of Tank and a Proximity sensor on the outside of the tank to disengage the Vacuum pump when the tank is full.
- 2.2 The clean water compartment is complete with 3 x fisheye glass type level indicators, fitted with Baffle Plates (Prevent Water Surge), Drainage / Inspection Sump and a 100mm Drain Valve.
- 2.3 Loading of the water compartment by means of 75mm filling connection with quick coupling and non-return valve with open flow into top of tank or by means of gravity through the manhole.
- 2.4 A separate polyurethane 30Lt water tank with 19mm tap shall be fitted at strategic Place on Unit for the Washing of Hands, etc.
- 2.5 Design pressure: +4bar; test pressure: +2bar; working vacuum/pressure: -1/+1bar.
- 2.6 Suction dome, complete with over-flow safety valve (primary shut-off).

- 2.7 Hinged manhole dia.480mm for the internal inspection of the clean water compartment.
- 2.8 Safe Access ladders with non-slip surfaces and harness attachment points on the side of the tank.
- 2.9 Full opening rear door with overhead hinges, open and close by means of hydraulic cylinders complete with built- in fail safe system to prevent the accidental closing of the lifted door in case of heavily damaged hydraulics.
- 2.10. Auxiliary Suction size 100mm (4") with knife valve and hose coupling.
- 2.11. Closing of the rear door by means of 4 x Hydraulic operated clamps.
- 2.12. Tightness of the rear door guaranteed by a large, dimensioned neoprene gasket.
- 2.13. The tilting of the tank is by means of a heavy duty hydraulic telescopic type cylinder, fixed on the front head and a mechanical rest to keep the tank lifted during maintenance work.
- 2.14. Sub-frame in steel, duly rust proofed to fit the chassis dimensions and to accommodate the above, described tank and components.

3. VACUUM SYSTEM

 Jurop model PVT400 Vacuum pump (OR EQUIVALENT) with rotary lobes (oil free) be fitted on the side of the truck on a steel-bearing frame. The pump is operated and driven from the splitter box unit with PTO's. Pump to be set only for suction of wet waste.

4. PERFORMANCE

- Minimum 2130M3/HR @ 0% Vacuum (Equal or greater)
- Minimum 1730M3/HR @ 60% Vacuum (Equal or greater)
- Minimum Power: 55kw (Equal or greater)
- Suggested working speed: 2900RPM (2 speed variable setting)
- Air injection cooling system
- Non-return check valve.

The system shall include the following features:

- Easy, removable Stainless, steel Strainer inside Tank door.
- A primary shutoff and a secondary Cyclone with sight glasses.
- Adequate vacuum and pressure relief valves
- Exhaust Silencers and oil trap

5. GULLY ARM

Top mounted pivoting 150mm diameter gulley arm, hydraulically operated is attached to the vacuum tank via a 150mm diameter swivel joint. The Lifting/Lowering and rotating of the Gulley Arm is Hydraulically Controlled with variable speed. The controls at the mounted in a lockable compartment behind the truck cab. The unit is supplied with 150mm heavy duty rubber hose fitted with a 150mm to 100mm reducer to accommodate the 100mm suction hoses.

6. SEPARATOR

 Primary shut-off and a secondary cyclone-type separator works as a trap for over-flow foams or liquid directed to the vacuum pump. It is placed between the tank and the vacuum pump. The secondary is complete with level sight glass, with manual ball drain valve.

7. AIR FILTER

• Suction filter with stainless steel mesh cartridge, fitted in the suction line of the vacuum pump for further protection of this unit.

8. HIGH PRESSURE CIRCUIT

High Pressure Pump

- Triplex plunger high pressure pump, Pratissoli Model MWR45 (OR EQUIVALENT), laterally Fitted on the steel-bearing frame (Suitable for Recycled Water) OR Similar to above mentioned.
- Main performance:

Power intake : Minimum 60kW (Equal or greater)

Max. water flow: Minimum 262 L/MIN (Equal or greater)

Operating pressure: Minimum 120 BAR (Equal or greater)

 It is complete with manometer and connecting pipes to the tank and to the hose reels.

9. PRESSURE REGULATING VALVE

Automatic pressure regulating valve.

10. WATER FILTER

 Water filter with stainless steel filtering cartridge suitably rated for the HP Pump flow.

11. REAR HYDRAULIC PIVOTING HOSE REEL

- Mounted on the rear door of the tank.
- External reinforced arms for the drum.
- Hydraulic rotation, complete with rotating coupling, flywheel, chain, pinion and hydraulic motor.
- All in one directional control valve complete with flow adjustment for the winding/unwinding of the hose.
- Hydraulic motor and controls for adjusting the rotation speed of the reel.
- Pivoting angle of approx. 180 degrees.
- 120mt. Dia. 1" high pressure hose, of textile-reinforced type and couplings.
- To grant easy working conditions all controls and valves are within the operator's working area.

12. ÀDDITIONAL MANUAL HOSE REEL ASSEMBLY FOR HIGH PRESSURE WASHING

• A manual hose reel with 30m of ½" high pressure hose, spray gun for high pressure washing fitted to left rear section of the truck chassis.

13. TRANSMISSION AND DRIVE

- Drive taken from drive line Split Shaft Unit with 2 X PTO's for the Vacuum Pump and the HP Water Pump. 1 x PTO for the hydraulic pump.
- Drive of the pumps by means of shaft, v-belts, pulleys and cordon-propelled shaft via pneumatic clutches.
- The pumps and hydraulics work independently while the truck is stationary and on idle.

14. HYDRAULIC PLANT

- The power to all of the other operating devices (Suction boom, rear door opening, tank tilting and hose reel) is by means of suitable hydraulic circuits with adequate control.
- An oil tank of suitable capacity for the hydraulic system, complete with filter, sight glass and gate valves for the connection to the hydraulic circuit.

15. MAIN CONTROL PANEL & SAFETY CONTROL

 All controls for the operation and working of the machine are fitted in a weatherproof illuminated control box. The panel can be easily removed for maintenance by means of a quick connect electrical plug.

The unit includes the following:

- Main Switch and Emergency stop
- Water pressure gauge
- Vacuum gauge
- Variable RPM switch Engine throttle control
- Engage/Disengage High Pressure pump
- Engage/Disengage vacuum pump
- Open/Close suction Boom Valve
- Water to reel on/off
- Clean tank indicator
- Hour meter
- Working light switch
- Low water warning buzzer and light
- Low level cut-out when engaged sensor indicator light
- · Vacuum tank high level when engaged sensor indicator light
- Light to indicate if the vacuum pump is running hot
- Light to indicate if there is water present in the cyclone.
- A watertight Hella plug for a remote spotlight
- Lights to be fitted on tank to provide lighting around truck when working at night

16. WATER TANK SAFETY

 A Low- Level Water Safety System Comprising of 2 Float Switches, one Higher than the Other. The First Operated with a Red Flashing Strobe Light and the Second Float Switch Operates an Intermittent Hooter Alarm when the Water reaches the 1000L Level. A Water Level Sight Glass is Fitted to Water Tank.

17. HYDRAULIC CONTROLS

- Hydraulic control for the tilting of the tank, with flow adjustment at rear of the truck chassis.
- Hydraulic control for rear door opening at rear of the truck chassis.
- Hydraulic control for the winding/unwinding of the hose reel and the operating the suction boom are positioned at rear of the truck chassis.

18. SUB-FRAME

 Semi Open tray (304L stainless steel) with lockable brackets on L/H side of tank (500mm wide – 200mm deep) including 4 x 3M of 100MM Kanaflex Suction Hose (OR EQUIVALENT) fitted with male and female perrot couplings and a 150mm x 100mm reducer and a 1M Steel Suction Pipe with Female Perrot Quick Coupling (OR EQUIVALENT).

- Closed Hose Tray (304L stainless steel) on R/H side of Tank with 3 x separate Compartments and lockable lids for storing tools, protective clothing and nozzles.
- 1 x 150mm Heavy Duty Vice Mounted at Rear of Truck.

19. WARNING LIGHTS AND REARVIEW CAMERA

- 2 x Amber Rotating Lights shall be supplied and fitted on either side of the rear section of the tank.
- 1 x LED Flood/Working Light shall be mounted at rear of vehicle.
- A Fail-Safe System is fitted to prevent the vehicle from being driven with PTO engaged.
- A warning light is fitted on the truck dashboard to indicate that the PTO is engaged.
- A rearview camera shall be supplied and fitted including monitor screen within the cab.

20. PAINTING

 Prior to painting the tank is stripped down and surface preparation is according to ISO 12944-4-6.1 and painted with 2 x coats of DTM (OR EQUIVALENT) corrosion proof paint with final DFT of 80 – 120um to match the colour of the truck cab.

21. TRUCK CHASSIS INCLUDED

 This quotation is based on a suitably rated new ISUZU FXZ 26 - 360 (Wheelbase: 6010mm), 6x4 truck chassis AMT 5transmission OR EQUIVALENT.

22. NOZZLES

The following nozzles must be provided:

- 1 X ENZ 1" (30.100) Retro Jet Nozzle (OR EQUIVALENT)
- 1 X ENZ 1" (40.100) 3.7KG Grenade Bomb Nozzle (OR EQUIVALENT)
- 1 X ENZ 1" (60.100) Pointed Nozzle (OR EQUIVALENT)
- 1 X ENZ 1" (10.125TRSETCH) Chain flail Nozzle kit for 100mm to 250mm lines (OR EQUIVALENT)
- 1 X CUTTER NOZZLE (OR EQUIVALENT)

All nozzles made from ware resistant hardened steel with a sturdy surface and thickness for a long service life and minimum wear.

General Conditions of Contract

1. <u>Definitions</u>:

- 1. The following terms shall be interpreted as indicated:
- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the goods are so delivered and a valid receipt is obtained.
- 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be

imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the goods covered by the bid will be manufactured.

- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 "Supplier" means the successful bidder who is awarded the contract to maintain and administer the required and specified service(s) to the State.
- 1.26 "Tort" means in breach of contract.
- 1.27 "Turnkey" means a procurement process where one service provider assumes total responsibility for all aspects of the project and delivers the full end product / service required by the contract.
- 1.28 "Written" or "in writing" means hand-written in ink or any form of electronic or mechanical writing.

2. Application:

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services (excluding professional services related to the building and construction industry), sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General:

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 Invitations to bid are usually published in locally distributed news media and on the municipality/municipal entity website.

4. <u>Standards</u>:

- 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.
- 5. <u>Use of contract documents and information inspection:</u>
- 5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the provider in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the provider's performance under the contract if so required by the purchaser.
- 5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent rights:

- 6.1 The provider shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.
- 6.2 When a supplier developed documentation / projects for the municipality or municipal entity, the intellectual, copy and patent rights or ownership of such documents or projects will vest in the municipality or municipal entity.

7. Performance security:

- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
 - a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque.
- 7.4 The performance security will be discharged by the purchaser and returned to the provider not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified.

8. <u>Inspections, tests and analyses:</u>

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a bid condition that goods to be produced or services to be rendered should at any stage be subject to inspections, test and analyses, the bidder or contractor's premises shall be open, at all reasonable hours, for inspection by a representative of the purchaser or an organization acting on behalf of the purchaser.
- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the goods to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the goods or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such goods or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Goods and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract goods may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected goods shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with goods which do comply with the requirements of the contract. Failing such removal the rejected goods shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute goods forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected goods, purchase such goods as may be necessary at the expense of the supplier.
- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing:

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents:

10.1 Delivery of the goods and arrangements for shipping and clearance obligations shall be made by the supplier in accordance with the terms specified in the contract.

11. Insurance:

11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified.

12. <u>Transportation</u>:

12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified.

13. Incidental services:

- 13.1 The supplier may be required to provide any or all of the following services, including additional services, if any:
 - (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
 - (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
 - (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
- 13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the provider for similar services.

14. Spare parts:

- 14.1 As specified, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:
 - (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
 - (b) in the event of termination of production of the spare parts:
 - advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty:

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this

- contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
- 15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise.
- 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.4 Upon receipt of such notice, the supplier shall, within the period specified and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment:

- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified.
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated.

17. Prices:

17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the provider in his bid, with the exception of any price adjustments authorized or in the purchaser's request for bid validity extension, as the case may be.

18. Variation orders:

18.1 In cases where the estimated value of the envisaged changes in purchase does not exceed 15% of the total value of the original contract, the contractor may be instructed to deliver the goods or render the services as such. In cases of measurable quantities, the contractor may be approached to reduce the unit price, and such offers may be accepted provided that there is no escalation in price.

19. Assignment:

19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts:

20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under these contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. <u>Delays in the Supplier's Performance</u>:

- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the goods are required, or the supplier's services are not readily available.
- 21.4 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.
- 21.5 Upon any delay beyond the delivery period in the case of a goods contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties:

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. <u>Termination for default:</u>

- 23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
 - (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;

- (b) if the supplier fails to perform any other obligation(s) under the contract; or
- (c) if the supplier, in the judgement of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- 23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction.
- 23.5 Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchaser actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
 - (i) the name and address of the supplier and / or person restricted by the purchaser;
 - (ii) the date of commencement of the restriction;
 - (iii) the period of restriction; and
 - (iv) the reasons for the restriction.
 - These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.
- 23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.
- 24. Anti-Dumping and Counter-Vailing duties and rights:
- 24.1 When, after the date of bid, provisional payments are required, or antidumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-

dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the supplier to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the supplier in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.

25. Force Majeure:

- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. <u>Termination for insolvency</u>:

26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of disputes:

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Notwithstanding any reference to mediation and/or court proceedings herein.
 - (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
 - (b) the purchaser shall pay the supplier any monies due to the supplier for goods delivered and / or services rendered according to the prescripts of the contract.

28. Limitation of liability:

28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;

- (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and
- (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

29. Governing language:

29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

30. Applicable law:

30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.

31. Notices:

- 31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.
- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

32. Taxes and duties:

- 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid SARS must have certified that the tax matters of the preferred bidder are in order.
- 32.4 No contract shall be concluded with any bidder whose municipal rates and taxes and municipal services charges are in arrears.

33. Transfer of contracts:

The contractor shall not abandon, transfer, cede assign or sublet a contract or part thereof without the written permission of the purchaser.

34. Amendment of contracts:

34.1 No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the

contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.

35. Prohibition of restrictive practices:

- 35.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is / are or a contractor(s) was / were involved in collusive bidding.
- 35.2 If a bidder(s) or contractor(s) based on reasonable grounds or evidence obtained by the purchaser has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties are contemplated in section 59 of the Competition Act No 89 of 1998.
- 35.3 If a bidder(s) or contractor(s) has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.
