Bidders must be registered with the CIDB, and it is estimated that bidders should have a grading designation of **6ME** or higher.

Only those tenderers who have in their employ management and supervisory staff satisfying the requirements of the scope of work and who have completed the NQF level 5 course in Labour-Intensive Construction.

Prospective bidders that join 15 (fifteen) minutes after the advertised time will not be allowed to attend the meeting or to be included on the attendance registers, unless the person chairing the meeting gives permission to do so. Reasons for the chairperson's decision must be noted.
