NOTICE OF PUBLIC PARTICIPATION PROCESS IN TERMS OF REGULATION 34(3)(b) OF THE MUNICIPAL FINANCE MANAGEMENT ACT, 2003: MUNICIPAL ASSET TRANSFER REGULATIONS, 2008

Notice is hereby given in terms of Regulation 34(3)(b) of the Local Government: Municipal Finance Management Act, 2003 (Act 56 of 2003): Municipal Asset Transfer Regulations, 2008 that the George Municipality intends to:

- Grant a long-term right to an external entity to use, control and manage the proposed George Biosolids Beneficiation Facility (BBF) located at the Gwaing Wastewater Treatment Works with a value in excess of R10 million, and
- Enter into a long-term agreement with the external entity for the operation and maintenance of the proposed George BBF for a period of ten (10) year (Tender T/ING/002/2024).

Notice is hereby further given in terms of Section 21 and 21A of the Local Government: Municipal Systems Act, 2000 (Act 32 no. 2000) that the local community and affected parties are invited to submit comments or representations for a period of sixty (60) days.

A copy of the information statement outlining the project background, reasons for the proposal, expected benefits, proceeds, gains and losses by the Municipality in terms of the proposed contract as well as the procedure for providing comments (section 2.3 of the information statement) is available for inspection during office hours at the Old Town Hall located on the corner of York and Market Streets, George and is also available on the Municipal website, www.george.gov.za.
