

T1.1: TENDER NOTICE AND INVITATION TO TENDER

Tenders are hereby invited for the:

<u>SUPPLY AND DELIVERY OF STREET / AREA LIGHTING EQUIPMENT AND ASSOCIATED STOCK ITEMS FROM DATE OF</u> <u>APPOINTMENT TILL 30 JUNE 2028</u>

Suitably qualified, capable and experienced service providers are hereby invited to submit tenders for the above contract for George Municipality from the date of appointment until 30 June 2028. The various equipment / material stock items required have been broken down into various categories, and may be awarded in accordance with the following:

Bidders do not have to submit a bid for each category, and may bid for any or all of the above categories. The bids will be adjudicated and awarded per category, but are not mutually exclusive and more than one category could be awarded to the same Bidder.

Bidders are to note that for contingency reasons it is envisaged that a 'Preferred' Bidder and a fallback 'Alternate' will be appointed per category, with the distribution of work subsequent to appointment subject to the Municipality's discretion.

Completed tenders in sealed envelope, clearly marked "Tender No. GMT 009/24-25: Supply And Delivery Of Street / Area Lighting Equipment And Associated Stock Items From Date Of Appointment Till 30 June 2028" must be placed in the tender box at the George Municipality on the First Floor, Directorate: Financial Services, Supply Chain Management, Civic Centre, York Street, George by no later than 12:00 on Friday, 16 May 2025. Tenders will be opened on the same day in the Committee Room at 12:00. Late or unmarked tenders will not be considered. No tenders per fax or e-mail will be accepted.

All documents must be ordered at least 2 days in advance. Proof of the above-mentioned payment must be presented to Clinkscales Maughan-Brown upon collection of a document. No document will be released without proof of payment, and Clinkscales Maughan-Brown will not accept any payment.

Compulsory Clarification Meeting

A compulsory clarification meeting with representatives of the Employer will be held at the Electro-Technical Services Directorate, Brick Road, George on Thursday, 17 April 2025 at 11h00.

Bidders should be represented at the compulsory clarification meeting by a technical employee from the prospective bidder who is suitably qualified and experienced to comprehend the implications of the work involved. An attendance register requiring signatures of all attendees will be circulated at the compulsory clarification meeting.

Prospective bidders that join 15 (fifteen) minutes or more after the advertised time of the compulsory clarification meeting has started, will not be allowed to attend the meeting or to sign the attendance register. If a prospective bidder is delayed, he / she must inform the contact person before the meeting commences and will only be allowed to attend the meeting if the chairperson of the meeting, as well as all the other bidders attending the meeting, give permission to do so.

Tender Eligibility Criteria

Only Tenderers who comply with the following criteria are eligible to submit tenders:

• A Bidder must demonstrate previous experience in the supply of street / area lighting equipment and associated stock material up to a minimum accumulative value of R 1mil, incl VAT over the last three years.

Price and Preference

Tenders will be evaluated and adjudicated in terms of the Preferential Procurement Policy Framework Act (Act 5 of 2000) Regulations 2022 and the George Municipality's Supply Chain Management Policy, as well as the George Municipality's Preferential Procurement Policy, where 80 points will be scored for price and 20 points for B-BBEE status and specific goals.
